The address for your GPS navigation system is: 185 Luther Jones Rd., Jackson, OH 45640.

The FT Grounds are located about 10 miles SE of Jackson, OH.

1. From the north: Pickup US-35E off SR-32/124E (about 1 mile east of Jackson) and follow US- 35SE about 6 miles.
2. Turn right onto OH-327 (to head NE) and travel 1.6 miles.
3. Turn right at CR-9 and travel 0.1 miles.
4. Turn right at Luther Jones Rd./Township Hwy 152 and travel 0.8 miles to 185 Luther Jones Rd.

From the south (if arriving on US-35W) exit onto OH-327 (about 6 miles SE of Jackson) and drive NE 1.6 miles to CR-9 -turn right at CR-9 and travel 0.1 miles to Luther Jones Rd. -turn right at Luther Jones/Twp 152 and travel South 0.8 miles to address #185.
